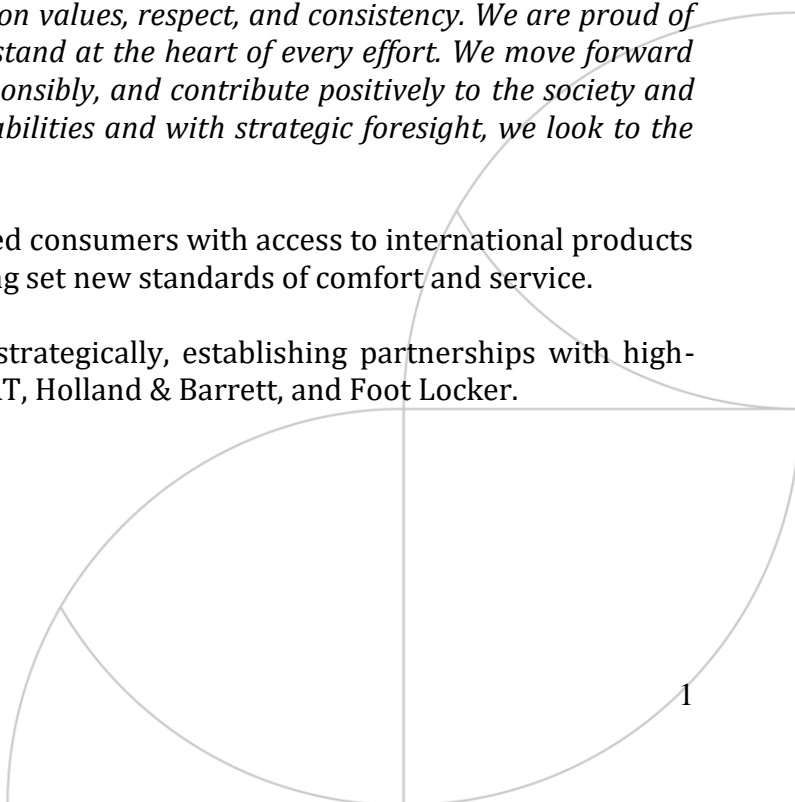
In his remarks, Vassilis Fourlis, Chairman of Fourlis Group, stated:
